

BOARD MEETING  
May 13, 1968 1530 Idaho St.

The purpose of the meeting was to hold a formal hearing concerning complaints received from guests of outfitter J. B. Taylor. Mr. Taylor was present, his attorney, Mr. Homer Martin, and Mr. Daniel Slavin, Hearing Officer. Due to the late arrival of Mr. Al Tice, the meeting did not convene until 11 a.m.

Letters were presented in evidence and witnesses were heard, with the proceedings recorded on tape. The hearing was concluded at 7:30 p.m. at which time a recess was taken.

The meeting reconvened at 9 a.m. on May 14, and the following unanimous decision was reached on a motion by Mr. Tice, seconded by Mr. Johnson.

The Outfitters and Guides Board hereby orders that the license of Mr. J. B. (Jim) Taylor be revoked pursuant to findings made upon a formal hearing held on the 13th day of May, 1968, upon the revocation or suspension of said license. Such order of revocation shall be held in abeyance subject to stipulation of counsel meeting the satisfaction of the Outfitters and Guides Board or until said stipulation is violated by Mr. J. B. (Jim) Taylor.

The Board reviewed the letter presented by the Flying Resort Ranches requesting more big game hunting area. Their finding was that Mr. Dan O'Connor had been licensed for many years for the South Fork of Sheep Creek and that had been his boundary line since the area system has been in effect. Flying Resort Ranches applied for this area for the first time in 1964 and it was included in their license pending further research and was subsequently designated a joint use area with Joe Blackburn.

A letter was written to Mr. Monty Nelson, Alpine, Wyo., who wanted to let his guests hunt over into Idaho. He was advised to contact Mr. Vaughn Haderlie who is licensed in Idaho for the area in question.

The request of Mr. Lon Jarvis for the area formerly licensed to Mr. Glenn Guthrie was denied and a letter is to be written to him to that effect.

The area applied for by Mr. Reynold Swenson was revised to conform to neighboring boundaries and he is to be notified that he should complete his application if the changes meet with his approval.

The secretary was instructed to write to neighboring states for their residence requirements for outfitters and guides.

A letter is to be written to Mr. Rolla Briggs who is chairman of the Outfitters & Guides Assn. committee which is investigating alleged violations and complaints by the Forest Service and Fish & Game Dept. against outfitter Clarence McReynolds. Mr. McReynolds had requested that the Association intercede for him.
