

OUTFITTERS AND GUIDES BOARD

Boise, Idaho

April 19-24, 1971

Members present: James F. Baughman and H. W. Guth. Mr. Holmes and Mr. Renshaw sent word they could not be present until April 20. Since there was not a quorum the meeting was not convened until April 20

Members present: James F. Baughman, Vice Chairman, H. W. Guth and R. J. Holmes. The meeting convened at 9:30 a.m.

Complaints against the Diamond D Ranch, Inc. were reviewed. Mr. Tom Demorest, manager, appeared at 10 a.m. to answer to the complaints and the fact that he had no licensed guides last year. He gave a complete rundown on all complaining parties, which was taped. He said he understood the law was changed to eliminate the licensing of guides, instead of just eliminating the bond.

The meeting recessed for lunch until 1 o'clock.

Mr. Renshaw arrived for the afternoon meeting.

Mr. Michael Brady, attorney for the State Tax Commission, appeared in answer to a subpoena. He was sworn and testified concerning a tax hearing for outfitter George Dovel, at which time Mr. Dovel denied that he had any sales tax liability on the grounds that he had not operated commercially since the sales tax law became effective. Documents labelled Exhibit I through V were submitted as evidence and Mr. Brady's testimony was taped.

Mr. Ronald Horner appeared to request that he be licensed for the Hetherington area as he has purchased his stock and equipment. He has guided for Hetherington for the past two seasons and knows the area.

A motion was made by Mr. Holmes that Mr. Horner be licensed for the same area as Mr. Hetherington including two areas used jointly with Flying Resort Ranches, Inc. Seconded by Mr. Guth. Motion passed.

Leroy Fatouros appeared to request an area adjoining Yellowstone Park for bear hunting. He was told to see A. W. Angell and try to work something out with him to present to the board.

Mr. George May appeared to discuss applying for the Sheep Creek area formerly licensed to Jim Taylor. He said he has no deer hunting in his area and he needs to extend his season. He was advised to consult with the District Ranger as at one time he made a request that the area not be licensed for a commercial operation. The board felt there might be a possibility of licensing the more remote part of the area.

Phillip Johnson was licensed for the Muley, Peach and Gardner Creek drainages which had been licensed to Beulah Reeves prior to 1970 but was not included in her application for 1970.

The application of David Myers to guide for Dick Alfs was reviewed and denied for big game hunting because Mr. Alfs is licensed for fishing and bird hunting, only. He should make application for an outfitter license if he wishes to take big game hunters in the Sun Valley area. His guide license was issued for fishing and bird hunting.

H. H. Hepburn was denied additional area easterly from End Butte as this has been in the area licensed to Jim Renshaw for many years. His license was approved for the same area that he had in 1970.

Lafe Cox's application for additional area around Yellow Pine was denied because the area is licensed to Homer Prock. His license was issued for the same area as the previous year.

Ted Epley's request to have his boundary line along the North Fork Wolf Fang Creek was reviewed. The board found that his line has always gone to the head of North Fork Wolf Fang Creek but then followed Wolf Fang Creek to Porphyry Creek. The drainage of North Fork Porphyry Creek is in the area licensed to Louis Rebillet. The license was issued for the same area as previously.

The application of Arnolt Oswald for additional area around Rhoda Pt. was denied as it would encroach upon the areas of H. H. Hepburn and Jim Renshaw. The license was issued the same as in 1970.

The application of John Williams for the former Neal Silver area was reviewed. The northerly line was revised to eliminate an overlap with Arnolt Oswald, making it run along the ridge between Rhoda and Lizard Creeks instead of along Rhoda Creek.

Joe Scoble's application for bear hunting was denied because he does not have a big game hunting area. The license was issued for the other activities requested.

License applications were reviewed until 5:30 p.m. when the meeting recessed until 9 a.m. the following day, April 21, with members present, Baughman, Holmes, Guth, and Renshaw.

Mrs. Gladys Phelps appeared to request that the outfitter license and big game hunting area be issued in her name as she is divorcing Lyle Phelps and the license and area was in her name before she married Mr. Phelps. She was advised that the board's decision might hinge on action of the court.

A list of outfitters who had not submitted applications for licenses for the 1971-72 season was reviewed. Mr. Guth made a motion that a notice be sent those who hunt big game to remind them that their licenses expired on March 31, and their big game areas are open for application in accordance with the law. Second Mr. Holmes and approved unanimously.

Walt Mason appeared to see about getting an outfitter license for the area of the late Warren Brewer. An area was worked out, removing an overlap with Middle Fork Lodge and taking in some adjoining open area. He was advised to complete an application.

Capt. Turner appeared to give information regarding the operation of the Middlefork Ranch, Inc.

The meeting recessed at 5:30 p.m. to reconvene after a meeting with the Fish & Game Commission at 9 a.m. on April 22.

The meeting reconvened at 11 a.m. with members present, Baughman, Guth and Renshaw.

Wes Jaszowski appeared to ask the board to take action on the application of Western Wilderness Recreation, Inc. He explained the plans of the corporation and the qualifications of himself and three brothers to act as guides. The board reviewed the applications and references and approved them except for big game hunting. This was denied because of their lack of equipment and the guides' lack of experience. The area requested was not considered suitable for a commercial operation. Float boating on the Middle Fork of the Salmon River was denied because of the moratorium on new licenses.

John Dorr appeared to expedite his boating license application. Application approved.

Applications were reviewed until 6 p.m. when the meeting recessed until April 23, when it reconvened at 9 a.m. with Baughman, Guth, and Renshaw present.

Jack Lykins' failure to comply with Idaho law was discussed. His application was submitted without the necessary information and was returned to him for completion. He has not returned it. His area was declared open for application and he is to be notified to that effect with a copy of the notice to go to the district ranger.

The applicants for the Slate Creek area are to be asked to meet with the board at the Grangeville meeting on May 13. They are Colin Rhoades, Dale Jennings, and Joe Wilson. Don French's attorney, Jim Herndon, also requested a meeting through Mr. Wilkins.

Walt Mason and Christine S. Cieslik appeared and submitted an area release from Mrs. Warren Brewer and a revised application for an outfitter license.

Kent Taylor appeared at the request of the board. He explained our law requires corporations to have a license and also to name a managing agent who is a licensed outfitter, 36-5402(2) and 5413(11). A notice to this effect was drawn up and a motion made by Mr. Renshaw to send it to all corporate applicants. Motion seconded and approved.

Lauren Day appeared to make application for an outfitter license to establish a boys' camp to give basic camping and survival training. He was advised to complete his application.

Applications were reviewed until 6 p.m. and the meeting recessed till 9 a.m. April 24, with members present, Baughman, Guth, Holmes, and Renshaw.

The applications of Gary Madsen and Gene Nichols were approved to include the former Muscutt area, dividing it on the Primitive Area boundary along the ridge east of Wilson Creek.

Gary Maxwell appeared to explain his activities. His license was approved for hunting predators, birds, fishing, backpacking, trailrides, and float boating. Bear and cougar hunting was denied for lack of an available area.

The application of George Dovel was denied based on Idaho Code, Section 36-5409(c), 5402(2), and 5413(1).


The application of K. R. Strickler was denied based on Idaho Code, Section 36-5409(c) and 36-5413(2, 5, 7, and 8).

The application of Don Hatch was reviewed and a motion made by Mr. Holmes that his guides who are residents of Utah should pay \$150 for an Idaho license in compliance with the reciprocity clause in the Idaho law. Seconded by Mr. Guth and approved.
