

IDAHO OUTFITTERS AND GUIDES BOARD MEETING

Boise, Idaho

July 13, 14, 1971

Members present: James F. Baughman, Jim Renshaw, Lon Jarvis.

The meeting convened at 9:00 am.

Roy Strickler appeared to inquire if the Board would approve his application for the area formerly licensed to Kenneth Strickler. After hearing his plan of operation he was advised to complete an application.

Dale Von Steen, Fish and Game conservation officer from Pocatello appeared at the request of the Board to discuss outfitter operations in southeast Idaho. He indicated that the Fish and Game Department would like a greater harvest in Unit 78.

Recessed for lunch until 1:00 pm at which time board member R. J. Holmes joined the meeting.

Lynn Davis, George Redington and Lee Bridges appeared before the Board at the Board's request. Lee Bridges requested that he be licensed for the area south of Paris, Idaho, alleging that Lynn Davis has not used the area. Lynn Davis and George Redington claimed they used the area, but they had only 37 hunters and they are licensed for all of units 73, 74, 75, 77, and 78.

Ralph Pehrson, Fish and Game big game manager for the area said it is a critical area and they need a greater harvest. Lee Bridges said if he could get a small area near his ranch at St. Charles, he would release an area in unit 76 to Phil Revel so he could have a big game hunting outfitter operation from his ranch on the Blackfoot River. The Board took the matter under consideration and accordingly Bridges was approved for a small area south of St. Charles Creek with a mile on each side of the creek to be a joint use area for Davis and Bridges.

Mr. & Mrs. Phil Revel appeared and worked out an area in unit 76. Lee Bridges retained the privilege of hunting cougar and bear in the area. They were both approved for the area in unit 76 which is south and east of Bear River.

Steve Jordan appeared to find out why he was not licensed for the area he applied for, which area has been licensed for many years to Mackay Bar and Stepp Ranch. He claimed they do not use it and that he was offered a campsite permit. The Board said they would investigate this further.

The meeting recessed at 6:10 pm until 8:30 am. July 14, 1971.

Dale Ney and Loren Smith appeared. They requested that Mr. Ney be relieved of his duties as managing agent for Idaho Wilderness School, Inc. and Mr. Smith revised his application to request an outfitter license to act as managing agent. He said he arranged to have the bond submitted later that day.

Mr. Ney said he is not employing Dan Lord whose application he had signed.

License applications were reviewed.

The meeting recessed for lunch until 1:00 pm and reconvened with Baughman, Renshaw and Holmes present.

The outfitter license applications of L. Phelps and Gladys York were denied on the grounds that their applications were made prior to their divorce settlement and the information submitted does not reflect their circumstances at this time. Section 36-5413 (1). The Board will reconsider new applications which are to include financial statements and list confirmed hunter bookings.

The outfitter application of Don French was denied for the hiring and use of unlicensed guides, section 36-5413 (9).

George May's application for an area in the Payette National Forest for bear hunting was approved. This area is south and west of Highway 71.

The meeting adjourned at 8:15 pm.
