

OUTFITTERS AND GUIDES BOARD

Boise, Idaho

September 27-28, 1971

Members present: James F. Baughman, R. J. Holmes and Lon Jarvis.

The meeting was called to order at 9 a.m. by Vice Chairman Baughman.

Applications for licenses were reviewed. Chairman Rex Lanham arrived.

Mr. Ival Sies appeared in regard to part time employment as an investigator for the board.

The application of Kevin B. Wells for a guide license for power boating was denied as he failed to show any experience which would qualify him to run a power boat and his outfitter employer, Richard Norris, is not licensed for boating. His guide license was issued for other activities requested.

The applications for guide licenses from Tommy Nelson, Richard Aldous and Thomas H. Anderson were denied for power boating for lack of qualifying experience. The licenses were approved for other activities requested.

Robinson Bar, Inc., Patricia Young, managing agent, and Norman D. Garrison, guide, were denied licenses for big game hunting for lack of equipment and experience. Licenses were approved for fishing, backpacking, and trail rides.

The meeting recessed at 5:30 p.m. until 9 a.m. the following morning, with members Baughman, Holmes and Jarvis present.

The application for a guide license for Dallas Wyatt was denied pursuant to Idaho Code, 36-5409(c) for supplying false information on the application form, 36-5413(1).

The application for a guide license for Lea Bacos was denied because he is not in the employ of a licensed outfitter. Stan Miller, who signed the application, notified the board that Bacos is no longer in his employ.

The 1972-73 budget was reviewed. Mr. Jarvis made a motion that Mrs. Merritt's position be reallocated to Administrative Assistant 1, step 1, with an increase to step 2 for meritorious service, beginning October 1, as recommended by the Personnel Commission, salary \$641. She is also authorized to enroll in a management seminar conducted by the U.S. Civil Service Commission. Seconded by Mr. Holmes and approved.

Rules and regulations were reviewed, changes made and approved. They are to be referred to our attorney, John Croner, for review, and if they meet with his approval, he is to be asked to set up a formal hearing for their adoption at the earliest possible date. We would like to have the hearing before the December meeting.
