

OUTFITTERS AND GUIDES BOARD

Boise, Idaho

July 28, 1972

The meeting convened at 8 a.m. with members present: R. E. Lanham, chairman, James F. Baughman, Lon Jarvis, and R. J. Holmes.

Applications were reviewed and licenses issued.

George Fromm appeared to discuss his license with the board.

Mr. John Croner appeared to advise the board on a number of issues. He suggested that it should be made mandatory for outfitters to carry liability insurance. This could be included in proposed law changes to be presented to the next legislature.

The meeting recessed until 1 p.m.

Jess Taylor and Rex Lanham reached an agreement on their mutual boundary which is to be the trail east of Bear Trap Saddle, running south to the ridge between Lookout Creek and Range Creek, thence west to Lookout Mtn.

Correspondence was reviewed and replies drafted. A copy of the reply sent to those entering a complaint against Dick Norris should go to Hawley Hill.

Guide licenses were denied to Don R. S. Davis and Gary Wilkinson as the board was notified by their respective outfitter-employers, Eldon Handy and Omer Drury, that their employment with them had terminated. The application will be reconsidered if employment is obtained with another outfitter.

Licenses issued between meetings by telephone conference were confirmed. Voit Hudspeth, Jr. was denied float boating on the Main Salmon and Ronald Gillett on the Main Salmon and Snake Rivers because they have the minimum experience required on the Middle Fork and on no other rivers. When the required training trips have been made on the other rivers, their applications may be reconsidered. Their applications were approved for float boating on the Middle Fork. Kenneth L. Collins was licensed for float boating on the Main Salmon and Middle Fork and power boating was denied as our records do not show any experience in power boating.

John D. Dondero was licensed for floating the Salmon River and denied for the Middle Fork until he has had the required experience.

There being no further business the meeting adjourned at 5:30 p.m.
