

OUTFITTERS AND GUIDES BOARD MEETING

Shore Lodge, McCall, Idaho

December 2,3, 1971

The board met in special session at McCall prior to the convening of the annual meeting of the Idaho Outfitters and Guides Association, Inc. The meeting convened at 1:30 p.m. with vice-chairman Baughman, Jim Renshaw, R. J. Holmes and Lon Jarvis.

Bill Guth, Jr. appeared to request additional area so they can hunt on the trail to Swet Lake cabin and then to Dennis Lakes. Since there were no maps available the board agreed to look into the matter at a later date.

Homer Rhett called and requested a meeting with the board in January.

Chairman Lanham arrived at the meeting.

The minutes of the previous meeting were read. Renshaw made a motion, seconded by Jarvis, that they be approved as read. Motion passed unanimously.

The request of Gary Madsen for additional area for bow hunting on the Lemhi drainage was denied. The area is licensed to Ray Torrey who is a bow hunter and to Dare Anderson.

Mike Wilkins reported on his trip into southeastern Idaho. He arrested Nick Robinson for guiding without a license. He plead guilty. Wilkins arrested Don Sanderson from Wyoming for outfitting without a license. He plead not guilty and bond was furnished by Vaughn Haderlie. Some of the equipment was claimed by Haderlie. Trial is to be later before Judge Genevieve Young, Soda Springs.

Since the 3 o'clock appointment did not show, the meeting recessed for Jarvis and Lanham to attend the meeting of Middle Fork boaters then taking place.

The meeting reconvened at 4 p.m. with Lanham, Baughman, Renshaw and Holmes present.

Bill Freeland and Phil Killiam, Sandy, Utah, appeared to discuss their taking over the operation of John Dark on Meadow Creek. They are primarily interested in bear and cougar hunting. Their application was not complete but they discussed their plans. The district ranger had not signed the application as the forest service would like to reduce the number of camps in the area.

The meeting recessed at 5:30 p.m. until 9 a.m. on Wednesday.

The meeting reconvened at 9 a.m., with all board members present, to confer with representatives of the Forest Service.

Forest Service personnel present were: Sam Warren, Mike Rinehart, Ken Johnson, Jim Moorhead, Ervin C. Burrows, Don Biddison, Jerry Reese, Frank Elder, Jack E. Bills, John Hooper, Andy Arvish, John Emerson, Bill Holman, Bill Sendt, Art Seamans, William Hicks, Frank Rowland, David O. Lee, Hoyle L. Soronson, William S. Rozynek, Tom Kovilicky, and Ted L. Anderson.

50 Sam Warren talked about the plan for the Middle Fork. They plan a 50-50 split between commercial and private party launches with an 8-day turn around and a maximum of 26 people per trip. There will be no extra commercial trips as allowed in previous years. These regulations are for July

and August, only.

Frank Elder said plans are to reduce the number of outfitters launchings per day as private use increases on the Salmon River during June, July, and August.

There was a discussion on suspected illegal outfitters in a number of areas.

The meeting adjourned at 10:30 to allow attendance at the meeting for boaters.

Margaret O'Neil Candy has been issued a guide license and Wilderness River Outfitter & Trail Expeditions, Inc., and Joseph Tonsmeire licenses have been extended to include overnight cross country ski tours since the last meeting.
