Outfitters and Guides Board
Boise, Idaho

JUNE 1, 2, 3, and 4, 1983

Wednesday, June 1, 1983, a regular meeting of the Outfitters and Guides Board was called to order at 0835 by Chairman James Baughman, with the following members in attendance: Glen Foster, Harry Vaughn, Robert Salter, and new members, Bill Meiners and Scott Farr.

The first order of business was election of officers. Member Robert Salter nominated, Member Harry Vaughn seconded the nomination, and the motion passed unanimously THAT GLEN FOSTER BE ELECTED CHAIRMAN OF THE BOARD. A second nomination also carried as Member Harry Vaughn nominated, Member Bill Meiners seconded THAT BOB SALTER BE ELECTED VICE-CHAIRMAN OF THE BOARD.

Member Jim Baughman explained how the Board was formed and when the law was changed to include a representative of the general public. He expressed his concern in licensing where areas were not remote and in possible conflict with the local public. He also mentioned the informal conduct of the board meetings in the past, then turned the meeting over to the new Chairman.

Chairman Foster expressed great appreciation that was felt in Jim Baughman's work for the Board and his dedication. Member Bill Meiners said he felt some trepidation in trying to fill Jim's shoes.

Member Bob Salter advised that a formal vote is wanted on the Board's action on all consideration made by the Board, along with the listing of licenses issued, extended or denied from meeting to meeting to be a part of the Board minutes.

Outfitter Complaints were reviewed and their status of confidentiality unless action was initiated to suspend or revoke a license. Also mentioned was the 60-day limitation in the Outfitters and Guides law concerning a hearing procedure; that hearings before the Board are conducted to alleviate potential appeal costs because of the Board's limited budget.

A telephone call was made by the Chairman and Vice-Chairman to Idaho County Prosecuting Attorney, then Lee Nitz and Bob Brown appeared before the Board on their court case and the licensing for the Nitz Brothers Outfitters, Inc. which is pending.

Mr. Nitz and Mr. Brown advised they will plead guilty to the lesser misdemeanor charge, and make restitution to the Texas clients on their expense, as well as to the state of Idaho for the \$906.00 in non-resident license fees which had not been purchased. The Board asked for a release from the clients or proof that a satisfactory resolution had been made, prior to the license consideration.

Additional fishing area was requested, they will get the land manager's approval. Also the Board saw no problem in the Nitz Brothers taking in five Geologists to the War Eagle Mine, as it was not recreational activity.

Enforcement Business was discussed with Albert Lewis as he met with the Board. He explained his case on Ray Ralls and the warrant issued and his arrest. The activities of Randy Miller, B.S.U. were discussed and it was agreed he should be sent a letter with the Outfitters and Guides law explained. Albert further explained his problem of not being able to contact the Owyhee County Prosecuting Attorney, Clayton Anderson, on the Nichols and Robertson cases.

Deputy Attorney General Patrick Kole, Chief of Natural Resources came in to discuss working for the Board as their legal counsel. A copy of a contract will be forthcoming.

Harvey Whitten, Riggins, Idaho came before the Board to request additional area for permit elk hunting to be licensed in Fish and Game Unit 14 and cougar hunting between Vinegar Creek and the drainage of Bull Creek on the Salmon River, with use of his son's licensed jet boat for access.

Al Defler, Forester, Hell's Canyon NRA, Enterprise, Oregon came in about one of their Forest Service employees, Frederick Talbott, who has applied for a guide license but submitted a suspected false document for current first aid training. It will be investigated further by the Forest Service and a letter sent to the Board.

Robert Doppelt, Oregon River Experiences, Inc. managing agent from Eugene, OR appeared before the Board concerning a falsified Red Cross card which he admitted he had altered to obtain guiding on his outfitter license. He was advised this will be investigated further with the Attorney General's office on what penalty would be invoked. The format sheet for a request for exception to rule 26.a., and/or 26.b. was also requested by Mr. Doppelt.

Robert Salter left the meeting at 1555 as Roger and Randy Smith, Boise, came in to discuss licensing of their proposed rafting which they plan in conjunction with selling of float boats. They had submitted guide license applications and were approved for guide licensing on the South Fork of the Payette River, to work for outfitter Dan Rotthoff.

The meeting recessed at 1715.

Thursday, June 2, 1983, Chairman Glen Foster called the meeting to order at 0830, with all other members present.

Member Bill Meiners questioned whether Margaret Betchert would come under the Outfitters and Guides Act in her activity conducted in sight seeing expeditions to the Birds of Prey area. This will be referred to Attorney Kole at a later time.

The minutes of April 11 and 12, 1983 were read. Member Harry Vaughn moved, Member Bob Salter seconded, and the motion was passed THAT THESE MINUTES BE ACCEPTED.

George Harrington, Eagle, Idaho came before the Board for an opinion on whether a license would be needed for the Payette River Festival which is being put together for American Rivers Month. As the activities were explained, it was determined he would not need a license.

The minutes of April 12, 1983 meeting of the Board with the Forest Service, Bureau of Land Management and the Department of Fish and Game representatives were read. After discussion of the Agency Meeting minutes being made available to those representatives who were in attendance, it was determined that this would begin with the next meeting between the Board and the Agency people. Member Harry Vaughn then moved, Member Bill Meiners seconded, and the motion passed THAT THE MINUTES BE ACCEPTED AS CORRECTED, adding the list of those in attendance, and notation of such as a part of the minutes.

Chairman Foster suggested an agenda be prepared for the Agency meetings in the future.

Mike Ducharme, New Meadows, Idaho came before the Board concerning licensing of his new trailriding outfitter business which he is proposing to conduct on state leased land on the west side of Payette Lakes. He removed his fishing request for a later time, so that licensing might be expedited at present. Member Bob Salter moved, Member Harry Vaughn seconded, and the motion passed THAT MIKE DUCHARME'S LICENSE APPLICATION BE APPROVED ONCE IT IS COMPLETED.

Jim Thrash, New Meadows, Idaho appeared before the Board about licensing for elk and deer hunting in Fish and Game Units 19A and 24, as his main interest, but also for cougar and bird hunting, fishing, trailrides and backpacking. Licensing for spring bear hunting was not of interest, but he said he would also like to be considered for fall bear licensing, if approved. He is aware that others have applied for the same area. His application will be investigated, as well as theirs, was explained to him.

Hershel Coulter, Donnelly, Idaho, bringing along a tape recorder, came before the Board to register a protest concerning the Board's moratorium on licensing of new bear hunting. Also he mentioned he wants an area for elk and deer hunting, which he has already requested and is being researched for licensing, as well as wanting to be licensed to pack game out of the Warren/Burgdorf area presently licensed for cougar hunting. One other request was for float boating on the North Fork of the Payette River from McCall to the Sheep Bridge.

Mr. Coulter informed the Board of some suspected illegal activity which included a wounded bear and marijuana being grown on the South Fork and Sheep Creek area. Also mentioned was float boating by an outfitter on the Payette North Fork where boating guests were not using life vests.

Following Mr. Coulter's meeting, where letters of support by the Fish and Game Department had been read, Member Bob Salter advised he would schedule a Game Management representative from the Department of Fish and Game to discuss the bear moratorium issue and the Department's study at the Board's next meeting.

Board members discussed the inavailability of legal service to the Board, then Member Bob Salter moved, Member Scott Farr seconded, and the motion passed THAT THE CHAIRMAN TAKE WHATEVER ACTION NECESSARY TO ESTABLISH LEGAL COUNSEL FOR THE BOARD BY JULY 1, 1983, AND THAT THE CURRENT AGREEMENT BE TERMINATED AS OF JUNE 30, 1983.

Deputy Attorney General Pat Kole was contacted by the Board Chairman concerning falsified first aid cards being submitted for licensing, then Member Bill Meiners moved, Member Bob Salter seconded, and a motion was passed THAT THE BOARD INITIATE A PROGRAM TO BE PUT IN PLACE THAT ACTION WILL BE TAKEN THROUGH THE PROSECUTING ATTORNEY'S OFFICE IN THE HOME TOWN OF THE OFFENDER ON RESIDENT OFFENSES AND/OR A WARRANT BE ISSUED ON NON-RESIDENT OFFENDERS. After discussion, it was determined to table this motion until the issue was cleared with Attorney Pat Kole.

Randy Brink, Boise, who has purchased the Payette River business (3 sections of river) from Joe Leonard, came in to meet with the Board about licensing. Member Bob Salter moved, Member Scott Farr seconded, and the motion passed THAT WHEN THE APPLICATION IS COMPLETED FOR PAYETTE RIVER COMPANY AND RANDY BRINK, M.A., THAT THE LICENSES BE ISSUED.

The Board determined to initiate updated input concerning the moratorium on the Payette River sections for consideration of lifting the moratorium.

Board work follow-up from the meetings, signing of licenses and enforcement work assignment was discussed. Member Bob Salter will assign the enforcement work.

Recess was called at 1730.

Friday, June 3, 1983, all members reconvened, as Chairman Foster called the meeting to order at 0830.

Minutes of April 13, 1983 were read and Member Harry Vaughn moved, Member Bill Meiners seconded, and the motion passed THAT THE APRIL 13, 1983 MINUTES BE ACCEPTED AS READ. Then the Minutes of April 14 and 15, 1983 were read and Member Harry Vaughn moved, Member Scott Farr seconded, and the motion was passed THAT THE APRIL 14 AND 15, 1983 MINUTES BE ACCEPTED AS READ.

Attorney Thomas Cushman, Boise, appeared before the Board, representing his client, Steve Alley, Garden Valley, concerning a license denial. Mr. Cushman advised he is requesting a hearing and is challenging the Board's procedure in conducting their meetings with applicants for licenses and also in setting limits for licensing, citing Interstate Commerce law.

James Baughman joined the meeting as Outfitter Complaints were worked on. Member Bill Meiners moved, Member Scott Farr seconded, and the motion was passed THAT A LETTER BE WRITTEN TO GERALD RICHIE ADVISING A SETTLEMENT AGREEMENT HAS BEEN OFFERED FAIR TO ALL PARTIES AND PROMPT ACTION MUST BE TAKEN FOR RESOLUTION TO CLIENTS AND UPON RECEIPT OF EVIDENCE THAT THIS WAS DONE WITHIN 30 DAYS OF THIS LETTER, CONSIDERATION WILL BE MADE ON ISSUANCE OF A 1983-84 LICENSE BY THE BOARD.

Bee Longley and Mark Longley, dba Mountain Hosts, Ketchum/Sun Valley, Idaho appeared before the Board on licensing day-backpacking to be called Mountain Hikes, on several trails. Member Bob Salter moved, Member Bill Meiners seconded, and the motion passed THAT WHEN THE APPLICATIONS ARE COMPLETE FOR BEE LONGLEY DBA MOUNTAIN HOSTS AND MARK LONGLEY, THAT THEY BE ISSUED.

Russ Heughins, Idaho Wildlife Federation, came before the Board to discuss asset management and explain the Forest Service and Bureau of Land Management Draft on areas being classified for public sale disposal and the effect on access to our public lands and the animal winter range. He suggested this agency contact their congressional delegation to express their concern for the outfitting industry interests. Member Bill Meiners will draft a resolution for the Board's approval by the July 1, 1983 meeting.

Following a telephone call from the Pond's Lodge manager, Member Bob Salter moved, Member Scott Farr seconded, and a motion was passed THAT CLIFF OLIVE BE ADVISED THAT THE BOARD HAS CONSIDERED HIS BOAT RENTAL PROGRAM ON THE BUFFALO RIVER AND FEEL IT DOES NOT AT THIS TIME COME UNDER THE OUTFITTERS AND GUIDES ACT, AS DESCRIBED BY TELEPHONE TO THE BOARD OFFICE, JUNE 3, 1983.

Outfitting Business included review of area boundary adjustment for Middle Fork Lodge, Inc. and S-Bar-W Wilderness Outfitters, Inc. between Cameron Creek and Sliderock LO. Revised area description will be sent to each outfitter with copies to the Forest Service.

License extension for Howard Thompson, Grangeville was reviewed and Member Scott Farr moved, Member Bill Meiners seconded, and the motion passed THAT THE APPLICATION OF HOWARD THOMPSON FOR BOW HUNTING ONLY WITH HIS SELF-LIMITATION OF 6 HUNTERS BE ACCEPTED ONCE IT IS COMPLETED.

Member Bill Meiners moved, Member Harry Vaughn seconded, and the motion passed THAT THE BOARD HOLD THE APPLICATIONS OF DEEDS/HOFF AND ENGLISH UNTIL ALL INFORMATION IS IN.

Jerry Thiessen, Department of Fish and Game Wildlife Management, was contacted concerning a possible amendment of the Bear Moratorium to allow outfitters with fall elk and deer hunting privileges to take bear during the firearm (center-fire) season. Mr. Thiessen indicated that this would not harm the Moratorium in his opinion nor the Department's study, and it made sense. Member Bob Salter moved, Member Bill Meiners seconded, and the motion passed THAT THE MINUTES OF THURSDAY, JULY 9, 1981, PAGE 2, PARAGRAPH 7, RELATIVE TO MORATORIUM ON LICENSING OF NEW BEAR HUNTERS BE AMENDED TO PROVIDE, EFFECTIVE IMMEDIATELY, THAT ALL OUTFITTERS LICENSES ISSUED FOR DEER AND/OR ELK HUNTING IN NEW AREAS INCLUDE A PROVISIO ON THE LICENSE THAT BEAR MAY BE TAKEN DURING THE FIREARM (CENTER-FIRE) SEASON FOR DEER AND/OR ELK ONLY. THIS IS DONE IN ORDER TO PROVIDE A MEANS TO HANDLE AN INCIDENTAL TAKE OF BEAR DURING THE ABOVE DESCRIBED BIG GAME HUNTING SEASON.

Action was then taken on licensing Forrest Wilson, White Bird, Idaho for outfitting in Fish and Game Units 14 and 19. Member Harry Vaughn moved, Member Bob Salter seconded, and the motion passed THAT THE FORREST WILSON APPLICATION BE APPROVED AS DEFINED FROM INPUT NOTES FOR ELK, DEER, SHEEP AND FALL INCIDENTAL BEAR HUNTING, FISHING, TRAILRIDES AND BACKPACKING. COUGAR HUNTING AND SNOWMOBILING BE DENIED.

Member Salter moved, Member Vaughn seconded and the motion passed THAT WHEN THE GLADYS YORK APPLICATIONS ARE COMPLETE, THEY BE ISSUED.

Member Salter moved, Member Farr seconded and the motion passed also THAT WHEN COMPLETE, THE APPLICATION FOR HARRY W. VAUGHN BE APPROVED.

The new application for licensing being completed, Member Bob Salter moved, and Member Harry Vaughn seconded THAT THE BIG CREEK PROPERTY OWNERS ASSOCIATION, INC. 1983-84 LICENSE BE ISSUED WITH DAVE STUCKER AS MANAGING AGENT. After discussion, Member Bill Meiners proposed a counter-motion THAT THE BOARD ASK THE ATTORNEY GENERAL'S OFFICE TO LOOK AT THIS PROPOSAL AND GIVE AN OPINION. Following additional input, Member Meiners recinded his motion. THE ORIGINAL MOTION PASSED BY MAJORITY VOTE, WITH TWO MEMBERS, FOSTER AND FARR VOTING AGAINST LICENSE ISSUANCE.

Colleen Sweeney met with the Board with a suggestion that a letter be sent by the Board to the Red Cross Chapter people to affect a better designed card to avoid the cards being altered. Member Salter suggested that at a future rules hearing, that rule 3.c.i. be changed (and all other rule reference) to require the original card rather than a photocopy be submitted to the Board which would be copied and returned with the license, and the first aid card be valid through the entire license year.

The meeting recessed at 1730.

Saturday, June 4, 1983, all board members reconvened at their Boise office boardroom at 0830.

Letters were determined to be sent on the Carl P. Russell Adventures--Hughes river transfer advising Jerry Hughes's attorney of the 13 clients names and addresses and request the trust fund monies be dispersed with record sent back to the Board within 45 days of the letter.

Member Bob Salter moved, Member Harry Vaughn seconded, and the motion passed THAT A SIGNATURE STAMP FOR CHAIRMAN GLEN R. FOSTER BE PURCHASED AND THAT ONLY THE ADMINISTRATIVE SECRETARY, EDYTHE I. BLELE, BE AUTHORIZED TO UTILIZE SAID STAMP IN APPROVAL OF LICENSES THAT ARE ISSUED SAME AS LAST YEAR, IN ACCORDANCE WITH IDAHO CODE 36-2109 (d).

Revision of maps to a standard size was offered by Member Bill Meiners. Member Harry Vaughn then moved, Member Scott Farr seconded, and the motion passed THAT BILL MEINERS BE AUTHORIZED TO PURCHASE MAPS AND OVERLAY MATERIAL HOLDING TO UNDER \$100.

License consideration was made on applications again as follows:

Member Bob Salter moved, Member Scott Farr seconded, and the motion passed THAT THE APPLICATION FOR A LICENSE AMENDMENT TO INCLUDE POWER BOATING ON THE LOWER SALMON RIVER BE ISSUED FOR STEVE J. WEIBER.

Member Bill Meiners moved, Member Scott Farr seconded, and the motion passed THAT DALE JENNINGS BE APPROVED FOR A LICENSE FOR BOTH BEAR AND COUGAR FOR THE AREA REQUESTED BUT NOT LICENSE THE JOINT-USE AREA WHICH WAS FORMERLY LICENSED FOR TARBOX.

Member Bill Meiners moved, Member Scott Farr seconded, and the motion passed THAT MR. PIRAM'S OBJECTION BE DENIED, THAT LOSS OF A LICENSE IN THE MAIL WAS BEYOND THE CONTROL OF THE BOARD AND THE REPLACEMENT FEE IS PROVIDED FOR IN THE LAW.

Member Bill Meiners moved, Member Harry Vaughn seconded, and the motion passed THAT THE APPLICATION OF BRUCE SCOTT BE DENIED BECAUSE INFORMATION RECEIVED FROM THE FOREST SERVICE INDICATES THAT NO SPECIAL USE-PERMIT MAY BE OBTAINED.

Member Bob Salter moved, Member Bill Meiners seconded, and the motion passed THAT THOMAS TWEETEN GUIDE LICENSE BE ISSUED NOT PROBATIONARY.



Board Business included past expense and projected income review. It was also determined to not purchase the telephone instruments as offered by Mountain Bell.

FS/BLM/F&G Business included letters which needed input, which Member Bill Meiners said he would address. Also a letter from the Middle Fork Ranger District regarding rejection of Ted Epley's request for permit for early and late Middle Fork of the Salmon River use.



The business of this meeting being completed, adjournment was called at 1730. A list of those licenses issued, extended and/or amended, or denied since the last meeting follow as a part of these minutes.
