

## MINUTES

Idaho Outfitters and Guides Board  
Boise, Idaho

August 3, 4 and 5, 1983

A regular meeting of the Idaho Outfitters and Guides Board was called to order by Chairman Glen R. Foster at 0845, with other members, Robert L. Salter, William R. Meiners, Scott Farr and Harry Vaughn present, meeting with Attorney General Deputies Kurt Burkholder, Clive Strong and Ms. Terry Eller.

Ms. Lydia Edwards, Idaho District 9 Representative came in with outfitter Hershel A. Coulter concerning the limitation of 6 elk and/or deer hunters approved for Mr. Coulter's 1983-84 outfitter license. During this meeting, Mr. Coulter was also advised that his new request for an area for spring bear hunting will be researched with the Department of Fish and Game, prior to the Board taking action.

Following the meeting with Representative Edwards and Outfitter Coulter, the Attorney General Deputies pointed out that the Board was on firm legal ground to place limitations by Idaho Code 36-2109 and 36-2110, quoting the Board's police power for protection of the resource, and also that it had been explained to Mr. Coulter his right for a formal hearing if he is unhappy with the Board's decision from this meeting.

Other matters brought before the attorneys were the open meeting law, requirement of license fees prior to board action, outfitters forming lease or contract agreements with guides rather than them being hired as employees, religious groups and schools coming under the Act, and falsified first aid documents submitted for licensing. The Attorney General's office will render written opinions for the Board.

Garn Christensen, Managing Agent of Sawtooth Outfitters and Guides, Inc., Boise came before the Board concerning setting up requirement criteria for survival training which could then be certified. Other rules needing certification criteria were mentioned which included technical mountaineering/rock climbing and cross-country skiing.

Randy Miller, Boise State University Outdoor Program instructor came before the Board concerning whether the university's outdoor program came under the Outfitters and Guides Act. Following this meeting and in consideration of the input received that it was educational rather than recreational, a motion was made by Member Harry Vaughn, seconded by Member Bob Salter and passed THAT THE BSU ACTIVITIES ARE CONSIDERED EDUCATIONAL AND NOT UNDER THE OUTFITTERS AND GUIDES ACT.

A telephone inquiry by outfitter Steve Guinn was discussed, and approval was given for Mr. Guinn to rent his boats to Lt. Governor David Leroy--lashing 3 together to use for a floating bar-b-que on Lucky Peak Reservoir, as it would not be under the Outfitters and Guides law.

David Waymire, Howe, Idaho, and his attorney, Charles Roos, Challis, Idaho came in to meet with the Board to appeal the denial of his outfitter license application. The fish and game violation that was the basis for the denial was discussed. The Board advised that a letter would be sent indicating their decision after review of the input, and that Mr. Waymire had a right to a formal hearing if the decision was not satisfactory.

Following this meeting, it was determined to again contact the Fish and Game Conservation Officer regarding the nature of the trapping citation registered against Mr. Waymire.

Outfitter Complaints were again reviewed on Gerald Richie, Darby, Montana, in that the check issued to Ron Lentz as an agreed upon settlement does not clear the bank. The Board will write to Mr. Richie and each of the three complainants, Msrs. Lentz, Dziak and Bellm to find out the status of their settlement agreement.

Rick Grunch, Hayden Lake, Idaho will also be written to concerning a hunting complaint which involved poor equipment, an unsatisfactory bear hunt, and ill treatment of the complainant's wife who was along on the hunt. He will be required to meet with the Board to explain these problems.

Other letters will be written as followup on complaints still pending on Rick Hussey and Bob Crick; also the Australian complainant's lack of response to Travis York's offer. He will be sent a registered letter requesting an acknowledgment. The Carl Russell/John Jones problem of \$1,300 deposit fees will be referred to the Attorney General's office.

Outfitter/Guide Business was reviewed. After consideration of the request of Kevin Bopp, a guide, to have his fee refunded because he could not work as a guide this year, a motion was made by Member Harry Vaughn THAT THE FEE BE REFUNDED. The motion was seconded by Member Scott Farr and passed. Concerning the request for a refund by guide applicant, Jim Traub, who did not want to pay the increased fee submitted for his training, there was a motion proposed by Member Harry Vaughn, seconded by Member Scott Farr which passed THAT THE LICENSE WOULD BE ISSUED FOR THE \$50 FEE SINCE IT WAS INITIATED AHEAD OF THE FEE INCREASE AND ADVISE THAT THE FEES ARE NON-REFUNDABLE ON NEW APPLICANTS, AND THAT BY ISSUANCE OF A LICENSE THIS YEAR IT WOULD BE AN EASIER PROCESS NEXT YEAR.

The meeting then recessed at 1700.

Thursday, August 4, 1983, the meeting was reconvened at 0845, with all members except Robert Salter present, meeting with Enforcement Officer Albert Lewis concerning Survival Schools operating in Idaho.

Following this meeting, Outfitter Business was continued: Steve Guinn will be advised that he could amend his license to include fishing on the reservoirs where he is supplying boating equipment; Richard Teller, Challis request for board reconsideration on a revised outfitter fishing area request will again be researched with the Department of Fish and Game; and, two complaints against outfitters, Ron Fudge and Vernon Johnson operating outside what is licensed to them will have letters sent for explanation.

One other outfitter problem included reading of a letter of complaint that Homer and Dennis Joseph had not followed up on a drop camp arrangement for some clients. A letter will be sent asking for their explanation.

Following the lunch recess, all members reconvened meeting again with Al Lewis concerning the cases he is working on.

The input given by David Waymire and his attorney was reviewed, along with input obtained by the conservation officer on the case, and the Board decision was THAT THE OUTFITTER LICENSE DENIED FOR 1983-84 WILL BE SUSTAINED BECAUSE OF THE FISH AND GAME VIOLATIONS, BUT THAT LICENSE FOR 1984-85 COULD BE CONSIDERED AND THESE VIOLATIONS WOULD NOT BE A PART OF THE CONSIDERATION.

Following review of new maps and a new letter outlining a requested bow hunting area received from Howard Thompson, Grangeville, the license extension issued July 13, 1983 was rescinded and replaced with an area in Unit #15 for 6 elk and/or deer bow hunters only.

Attorney Philip Gordon, Council, Idaho letter and partially completed application submitted for issuance of training cards to guide for outfitter Jerry Kooyers was read. A motion was made by Member Harry Vaughn, seconded by Member Robert Salter and passed THAT THE GUIDE LICENSE APPLICATION FOR PHILIP H. GORDON BE ACCEPTED WHEN COMPLETE.

The meeting recessed at 1800.

Friday, August 5, 1983, at 0830, all members of the Board reconvened.

Department of Fish and Game response letters were evaluated as license extension requests were considered for Harvey Whitten for permitted elk hunting in Unit 214-1 and additional cougar hunting along the main Salmon river from Vinegar Creek to Bull Creek. Member Harry Vaughn moved, Member Robert Salter seconded and a motion passed THAT THE BOARD ACCEPT THESE TWO EXTENSION REQUESTS.

Revision of area boundaries agreed upon by outfitters Larry Jarrett and David Cox, managing agents of the Lazy J Outfitters, Inc. and Double K Outfitters, Inc., respectively, were researched on the map and the Board determined that some wording would need to be corrected. A motion was passed as moved by Member Robert Salter, seconded by Member Harry Vaughn THAT WHEN A SUITABLE DESCRIPTION IS RECEIVED FROM LARRY JARRETT, THE REVISED AREAS BETWEEN JARRETT AND DAVE COX BE APPROVED. A copy of the revised areas will be mailed to the area forest service land manager upon approval.

A telephone call was taken from the Fernan District Ranger concerning revision of Rick Vander Meyden's area in Devil Creek and the new licensing/permit request of Michael Storaasli, Clark Fork. The Board determined that a letter will be sent to the Department of Fish and Game requesting clarification on additional licensing in the area with reference to the past four letters received from the Department which have conflicting viewpoints.

Pat Ford, Idaho Conservation League and Roger Williams, Idaho Fish and Game Department representatives came in to explain the Idaho Wilderness Bill. Following this meeting, the members drafted a letter which was approved to be mailed to Idaho Governor John V. Evans, with copies mailed to Senator James McClure, the Idaho Outfitters and Guides Association and the Idaho Department of Fish and Game.

The minutes of June 28, 29, 30 and July 1, 1983 were read and approved by motion made by Member Harry Vaughn, seconded by Member Bill Meiners THAT THESE MINUTES BE ACCEPTED AS READ.

Attorney General Deputy Clive Strong joined the meeting to discuss: licensing of survival schools; outfitters and guides schools; ski instruction; rock climbing schools; religious conferences; and the Russell/Jones client deposit trust fund. Mr. Strong will research and issue the Board an opinion by the next meeting.

Outfitter Business was worked on the balance of the day. The Nitz Brothers outfitter licenses are still not issued because the managing agent needs a current first card. A telephone call was made to Mr. Lee Nitz advising him and his guides of the date of the Lewiston Red Cross class on August 13th.

A motion was made following the contact with Lee Nitz, made by Member Robert Salter seconded by Member Harry Vaughn, and passed THAT WHEN APPLICATIONS ARE COMPLETE THAT A 1983-84 OUTFITTER LICENSE BE ISSUED TO LEE NITZ AND THE NITZ BROTHERS OUTFITTERS, INC., BOTH PROBATIONARY.

The input was reviewed on the license limitation issued to Hershel Coulter and Member William Meiners moved, Member Robert Salter seconded and the motion carried THAT THE BOARD, AFTER DUE CONSIDERATION OF THE PRESENTATION GIVEN IN MR. COULTER'S BEHALF BY REPRESENTATIVE LYDIA EDWARDS AND FURTHER IN CONSIDERATION OF THE INITIAL EFFORT BY THE BOARD TO ACCOMMODATE MR. COULTER'S WISHES AND DESIRES, THAT HIS LICENSE NOT BE AMENDED AT THIS TIME.

After discussion of Tom Hansen's telephone request to the office for refund of his license fee, Member Robert Salter moved, Member Scott Farr seconded, and a motion passed THAT TOM HANSEN BE REFUNDED THE OUTFITTER LICENSE FEE FOR 1983-84.

A letter from outfitter Robert Jonas wanting to help establish certification for technical mountaineering/rock climbing will be answered, with the Board requesting a detailed outline of his suggestions for their consideration.

Another letter received about Mitch Sanchotena, Boise, guiding unlicensed activities for Mackay Bar was noted. The Board determined to ask Mackay Bar Corporation's managing agent, Ken Olson to come in to the next meeting to discuss this problem.

Extension of a trophy deer hunting area for David Williams for a limited number of animals in the old Nye area will need the approval of the forest service land manager. A motion was made by Member Scott Farr and seconded by Member Harry Vaughn THAT THE BOARD WRITE DAVID WILLIAMS SENDING HIM THE SUPPLEMENTAL III FORM INFORMING HIM THAT IF HE CAN NEGOTIATE A PERMIT FROM THE FOREST SERVICE, THE BOARD WOULD CONSIDER HIS EXTENSION. The motion passed.

Member Harry Vaughn moved, Member Robert Salter seconded and the motion carried THAT STAN MEHOLCHICK'S APPLICATION FOR AN EXTENSION FOR FISHING IN UNITS 25 AND 33 BE ACCEPTED.

Member Harry Vaughn moved, Member Robert Salter seconded and a motion passed THAT THE AMENDMENT BE ISSUED WHEN COMPLETED FOR BOB LIMING AND JAMES HOLCOMB. A letter will be sent requesting the forest service land manager's approval on their request for back-packing and chukar bird hunting in Unit 18.

A motion was made by Member Harry Vaughn THAT STANLEY SWEET'S AMENDMENT BE ACCEPTED The motion was seconded by Scott and passed.

Steve Guinn's White Water Shops, asking for power boating on the lower Salmon River for steelhead fishing, will have a letter reply that no space is available but that he will be placed on the Consideration List.

Member Robert Salter moved THAT BECAUSE THE 1983 GUIDE LICENSE APPLICATION OF ROBERT W. LAMM WAS VERY SIMILAR TO THE 1982 LICENSE AND SINCE HIS 1983 LICENSE WAS DENIED, THAT THE \$50.00 FEE BE REFUNDED IN ACCORDANCE WITH SECTION 36-2108 (b)-2, IDAHO CODE. The motion was seconded by Member Bill Meiners and carried.

The board members reviewed John E. Anderson, Boise, license extension request and the following motion was made by Member Bill Meiners THAT IN ACCORDANCE WITH IDAHO CODE 36-2109 (b) 4 & 5 THAT MR. ANDERSON'S APPLICATION FOR LICENSE EXTENSION BE DENIED BECAUSE ON BASIS OF INPUT FROM FISH AND GAME NO ADDITIONAL COUGAR HUNTERS ARE NEEDED. The motion was seconded by Member Scott Farr and passed.

It was moved by Member Robert Salter, seconded by Member William Meiners and passed THAT OLIN GARDINER'S LICENSE BE EXTENDED TO INCLUDE THE MURTAUGH SECTION OF THE SNAKE AS REQUESTED. Mr. Gardiner is managing agent along with James Powell for Idaho Guide Service, Inc. and Salmon River Guide Service, Inc.

The extension for lead boatman by Curtis Chang, managing agent for Grand Canyon Dories, Inc. was also approved by motion of Member Robert Salter THAT CURTIS CHANG'S REQUEST FOR CHANGE IN GUIDE STATUS FROM BOATMAN TO LEAD BOATMAN ON THE SALMON RIVER, SPRING BAR TO LEWISTON BE APPROVED. The motion was seconded by Member William Meiners and passed.


Member Harry Vaughn moved THAT THE GEORGE DUNCAN AMENDMENT DESCRIPTION BE APPROVED BY THE BOARD FOR THE GEORGE MAY AREA WITH THE LARRY JARRETT AREA EXCLUDED IN THE NEW DESCRIPTION IN EXCHANGE FOR DUNCAN'S PREVIOUS DWARSHAK AREA FOR BEAR AND COUGAR. A second was made by Member Scott Farr and the motion was passed.

Robert Sherwood's request for technical mountaineering/rock climbing and cross-country skiing will require certification and his qualification submitted. A letter will be written to advise him.

An amendment requested by outfitter Harry Vaughn for elk, deer, bear, cougar and forest grouse hunting in the area he is currently licensed for trailrides will be researched with the Department of Fish and Game for input on the resource and public use.

A list of licenses issued, extended and/or amended, or denied since the last meeting is included as a part of these minutes. Also the past year's income and expense by month was prepared for the Board's review and is included with these minutes.

The meeting adjourned at 1800.
