STATE OF IDAHO OUTFITTERS AND GUIDES LICENSING BOARD

Boardroom - Boise, Idaho January 10, 1990

A special meeting of the Idaho Outfitters and Guides Licensing Board was convened at 1330 hours on Wednesday, January 10, 1990 for the purpose of considering Village Stables, Inc., dba Elkhorn Village Stables, Daniel P. Mulick, Designated Agent, outfitter amendment request for the conduct of wagon and sleigh rides as additional licensed activity under their current outfitter license. Urgency is necessary in that the next regularly scheduled Board meeting is not until the week of February 12-16, 1990 at which time a considerable portion of the season for sleigh riding would be passed.

A quorum of Board members is present for the conduct of this meeting, namely Ted Epley, Dale Baird, and Bill Meiners. Leo Crane and Hank Miller are absent. Board Executive Director, Dean Sangrey, and Board Attorney, Dallas Burkhalter, are also present.

Village Stables, Inc., dba Elkhorn Village Stables/Daniel P. Mulick, Designated Agent: Mr. Mulick met with the Board regarding his outfitter amendment request for the conduct of wagon and sleigh rides in conjunction with his other outfitted activities as currently licensed. Following an interview before the Board and discussion of this proposed amendment request, the following facts became apparent: 1) activities proposed by Mr. Mulick are those which will occur entirely on property owned by Elkhorn Village which lies entirely within the city limits of Sun Valley, Idaho; and 2) that a future request could involve the wagon and sleigh ride activity which would go off city property into Keystone Gulch, however, this is a matter which has not, as yet, been resolved by and between the applicant and the Blaine County Planning & Zoning Accordingly, MSC (Baird-Epley) THAT, IN VIEW OF THE FOREGOING FACTS, THE BOARD FINDS 1) THE AMENDMENT REQUEST IS FOR OF ACTIVITIES FALLING WITHIN THE PURVIEW OF CONTROL/ORDINANCE AS RELATES TO THE PUBLIC HEALTH, SAFETY AND WELFARE, 2) SUCH ACTIVITIES ARE THEREFORE OUTSIDE THE SCOPE OF IDAHO CODE, TITLE 36, CHAPTER 21, AND 3) APPLICANT DOES NOT REQUIRE LICENSING BY THE BOARD. FURTHER, UPON CONSIDERATION/RESOLUTION OF THE CONDITIONAL USE PERMIT NOW PENDING BEFORE THE BLAINE COUNTY
