March 30, 2016

A SPECIAL MEETING OF THE IDAHO OUTFITTERS AND GUIDES LICENSING BOARD WAS CALLED TO ORDER AT 1:49 P.M. ON MARCH 30, 2016 AS A CONFERENCE CALL ORIGINATING IN THE MEETING ROOM AT THE IDAHO OUTFITTERS AND GUIDES LICENSING BOARD OFFICE, 1365 N. ORCHARD STREET, ROOM 172, BOISE, IDAHO. CHAIRMAN HUNSUCKER CONDUCTED THE MEETING FROM THE IOGLB OFFICE IN BOISE. BOARD ATTORNEY ROGER HALES; OFFICE SUPERVISOR LORI THOMASON, AND ENFORCEMENT SUPERVISOR RANDY WADLEY WERE THERE IN PERSON. MEMBERS LOUISE STARK, BOB BAROWSKY, GEORGE MCQUISTON, AND TOM LONG WERE ON THE CONFERENCE CALL.

Reconvening case 15187-10 the Outfitter and Guide license hearing for Richard L. Hussey dba Quarter Circle A Outfitters continued from the March 24, 2016 Board Hearing. Mr. Hussey was called and was in attendance. It was noted that during the hearing on March 24, 2016 that Mr. Hussey had admitted to and the Board found Mr. Hussey guilty of three counts. Count I - Unprofessional Conduct, Count II - Engaging in Unlicensed Area and Activities and Count III - Employing an Unlicensed Guide. MSC (MOTION: STARK, SECOND, LONG; - AYES: MCQUISTON, BAROWSKY AND HUNSUCKER; NAYES: - NONE) BASED UPON THE FACTS AS PRESENTED TO THE BOARD RELATIVE TO COUNTS I, II, III AS DESCRIBED AND ADMITTED TO BY MR HUSSEY MOVE TO IMPOSE THE FINES OF \$2,500.00 PER COUNT WITH THE CONDITIONS THAT MR. HUSSEY'S 2016 LICENSES BE ADDRESSED IN A SEPARATE MOTION

DIRECTOR HOWARD ARRIVED AND WAS IN ATTENDANCE IN PERSON.

Payment arrangements - Discussion took place whether payment arrangements would be allowed for Mr. Hussey's payment of the fine. Board member Stark questioned whether Special Processing fees associated with Mr. Hussey's Outfitter license were applicable. Director Howard stated that with Mr. Hussey's license being deferred and not able to license until the hearing was concluded, the special processing fee would not apply. He later clarified that as long as Mr. Hussey submits his license renewal application and fees before the 31st of March 2016 there will be no penalty fees, but that if Mr. Hussey waits until April 1, 2016 a penalty fee would apply. Mr. Hussey was made aware of this during the teleconference. **MSC (MOTION: LONG, SECOND, STARK; - AYES: BAROWSKY, HUNSUCKER ; NAYES: - MCQUISTON) SHOULD MR. HUSSEY SO DESIRE, A PAYMENT PLAN FOR THE \$7,500.00 FINE COULD BE ARRANGED AT THE DISCRETION OF THE EXECUTIVE DIRECTOR FOLLOWING BOARD POLICY.**

Mr. Hussey 2016 License Application - **MSC (MOTION: LONG, SECOND, STARK; - AYES: BAROWSKY; NAYES: - HUNSUCKER) TO GRANT A 2 YEAR RESTRICTIVE PROBATIONARY LICENSE. MOTION AMENDED TO MAKE THE LICENSE A 5 YEAR RESTRICTED PROBATIONARY LICENSE STARTING THE DATE OF THE ORDER.** Board attorney Hales read from the Board's policy regarding restrictive probation and the fine in explaining matters to Mr. Hussey. Board member Stark questioned that if Mr. Hussey chooses to sell his business, whether the sale will need to come before the Board. It was discussed that he could sell his outfitter business provided the conditions in the Board's
